

#### **SAE REPORTING**

Remember serious Adverse Events (SAEs) that are not safety outcomes, SARS or SUSARS should not be reported. E.g. Neurological deterioration, haematoma expansion, cerebral oedema that is NOT thought to be related to the IMP, and does not result in death does not need to be reported as an SAE.

Please remember to anonymise the CT scan reports and drug charts and add the participant trial ID number to the document before uploading to the secure vault. Consent forms are not to be anonymised. CT scan images need to by anonymised but pseudonymised information maintained such as DOB.



#### **ORAL CONSENT PROCESS**

TICH-3 has received ethic approval for enrolment consent to be taken verbally due to the emergency nature of ICH. The only instance where written consent is obtained for enrolment is if an independent doctor is used if the patient does not have capacity and no relatives are present/contactable. Full, written informed consent is to be sought as soon as practicable, ideally within the next 24 hours.



#### **NIHR RESEARCH RESET**

Following the pandemic, the NIHR is taking urgent action to address the current clinical research delivery challenges in the NHS, termed the 'Research Reset' (more information can be found <u>here</u>). We believe TICH-3 satisfies the questions asked by NIHR.

Research question is still of importance - ICH is devastating

Care pathway for ICH is unchanged – there is currently no evidence for haemostatic therapies in standard care guidelines
